# COMMITTEE REPORTS

## Architectural Control Committee

There are no ACC requests at this time.

#### <u>Decks</u>

TNT Construction got Brian prices for the railings; Brian is writing owners with modified decks to determine if they want to pay for railing repairs. No starting date determined.

#### **Maintenance**

Brian will get starting dates for cement replacement and deck repairs..

Maker Enterprises bid the gutter cleaning for 2021 at \$2,350.00 – the same price as 2020. Salisbury motioned to approve the contract; Bullard seconded; vote was unanimous. There was a discussion of adding heat tapes to some gutters to help with ice build-up.

Murata Coatings should be painting the back decks of 1 through 21 this year in September or October.

#### Landscaping

Michele and Deb and Jeannette Carpenter and Brian Reid walked with Mike from M&M and made a list of small projects. He has already gotten much of the work done.

Michele said the new tenants at #12 have a truck that is too large to park in the community. Brian will write the new tenants. Commercial vehicles and vehicles over  $\frac{3}{4}$  ton are not allowed in the community, except for loading and unloading.

Daniel Niles from SavaTree said the tree trimming is not scheduled for a few more weeks.

## FINANCIAL STATEMENTS

The Association ended August 2021 with \$107,623.76. The HOA is operating with a deficit due overages in sprinklers, insurance fees and legal fees incurred this year.

Wilkinson motioned to approve the financials; Salisbury seconded; vote was unanimous.

#### NEW BUSINESS

The bid for the back decks was reviewed. Bullard motioned to approve the contract; Wilkinson seconded; vote was unanimous.

## OWNERS FORUM.

Jean McDonald asked about the awning at #1 - it is looking more damaged and needs replacement. There are new tenants at #20 - the owner needs to provide a lease. There are significant driveway cracks at unit #20 - they should be filled next year.

There being no further business, the meeting was adjourned at 4:02 p.m.
